



Subject: Procurement Contracts of \$25,000 or More



WHEREAS, Funds have been budgeted for the purchase of equipment, supplies, and contractual services; and

WHEREAS, Funds have been budgeted for the purchase and financing of ground maintenance equipment with related equipment accessories and supplies through Bid No. 001B7400203, in the amount of \$91,352; and

WHEREAS, Funds have been budgeted for the purchase and financing of various dump trucks through Bid No. 001B7400466, in the amount of \$150,965; and

WHEREAS, Funds have been budgeted for the purchase and financing of off-the-lot, new vehicles and equipment through Bid No. 1060169, in the amount of \$41,338 for the Division of Food and Nutrition Services and in the amount of \$170,478 for the Division of Maintenance totaling \$211,816; and

WHEREAS, The acquisition of ground maintenance equipment with related equipment accessories and supplies, various dump trucks, and off-the-lot, new vehicles and equipment through financing agreement has been reviewed by legal counsel; now therefore be it

Resolved, That ground maintenance equipment with related equipment accessories and supplies in the amount of \$91,352 be purchased and financed for a five-year term under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation; and be it further

Resolved, That various dump trucks in the amount of \$150,965 be purchased and financed for a five-year term under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation; and be it further

Resolved, That off-the-lot, new vehicles and equipment in the amount of \$41,338 for the Division of Food and Nutrition Services and in the amount of \$170,478 for the Division of Maintenance totaling \$211,816 be purchased and financed for a five-year term under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation; and be it further

Resolved, That the proceeds from the aforementioned financing be used to reimburse Montgomery County Public Schools accounts to the extent that such has been or will be acquired before closing; and be it further
