



Subject: Contract Approval for Request for Proposal No. 4290.5, Private Duty Nursing Services for Students with Special Needs—Extension

This is a request to approve the second of three possible one-year extensions for the contract awarded under Request For Proposal No. 4290.5, Private Duty Nursing Services for Students with Special Needs, to provide private duty nursing services for Montgomery County Public School students with special needs. It is recommended that the Board of Education approve this contract for one year through June 30, 2025.

WHEREAS, Funds have been budgeted for the contracts to multiple awardees to provide private duty nursing services for students with special needs in Montgomery County Public Schools through Request For Proposal 4290.5, in the total amount of \$3,200,000; now, therefore be it
