| 2. | The RFP states that the responses should follow each section of the RFP. Are we correct in assuming that the responses should cover RFP sections 1-6, or do we need to cover all 20 sections, which would add a tremendous amount of length to the proposal? | Cover all sections. If the section does not require a detailed/technical response, simply reply "Understand and Comply". |

The RFP states in one section that flash drives with electronic copies are desired and that electronic submittals are not accepted, and then in another section asks for 3 hardcopies and doesn't mention anything about flash drives. What exactly does MCPS require as a submittal? | Please refer to addendum number 1 which clarifies the submission instructions. |
| 4. | Is there a previous FCA report per school that can be shared? | Previous KFI report per school shall be shared for information only. |
| 5. | Can surveys be completed during school hours? | Surveys can be performed between 6:00 am and 5:00 pm, but instructional spaces are not accessible during school hours. |
| 6. | Can surveys be completed during weekends, and will MCPS staff be available to escort? | No surveys can be performed during weekend, holidays, and MCPS systemwide closures. Some schools provide summer programs, and instructional spaces may not be accessible during school hours even during summer break. |
| 7. | We plan to use drones for exterior and roof surveys. Will this be acceptable? | The use of drones is acceptable, but all local and federal regulations must be followed, and restrictions may apply. |
| 8. | Are building MEP plans available for each building? | Archive drawings are available including MEP plans, but they may not reflect the current conditions. |
