2. On page 5. K2-3 addenda/errata states "failure to acknowledge addenda/errata on form may result in bid being deemed non-responsive..." This is under the subheading for the price form but on the Appendix E price form there is no location for acknowledge of this paragraph, will a simple line item in our proposal saying we acknowledge the Addenda/Errata suffice?

Answer: Any addenda or Errata, such as this one, when issued, will be labeled as such, and will have a section at the bottom to acknowledge receipt. This must be submitted with your bid or under separate cover.
