1. What is the total allocated budget for this specific initiative?

Response: The budget allocation for this initiative will not be shared at this time.

2. Is there a set amount of how many students MCPS would like to participate?

Response: Ideally, we would like all High Schools to receive support from College Access Providers. The RFP specifically addresses the needs of first-generation students. However, the college access programming can also support all high school students and provide more individualized support for first generation students.

3. Can proposals include customized numbers of students at specific schools?

Response: Yes, responses may include customized numbers of students.

4. Is this RFP in any way part of the \$1.8million that will go to College Tracks to add five more schools?

Response: This is a new RFP requesting services to be provided in support of students to become college, career, and community ready.

11. What, if any, solution(s) is the district currently using to achieve the desired outcomes of this RFP?

Response: The district currently uses school-based staff and partnerships with organizations that support a subset of schools.

Response: This RFP will provide services to approx. 3,000 students and their families. We do not have a break down by grade level.

Response: Yes. The district is interested in using tools as a component of the in-person college and career readiness programming outlined in the RFP.
