The superintendent recommends that the Board of Education exercise the annual extension of Bid No. 7094.7, Aftermarket Automotive Parts—Extension, under the Annotated Code of Maryland, Education Article §5-112 and Montgomery County Public Schools Regulation DJA-RA, Procurement of Equipment, Supplies, and Services.

This is a request to exercise the second annual extension of the contract to multiple awardees under Bid No. 7094.7, for the purchase of Aftermarket Automotive Parts.
