Subject: Contract Approval for Bid No. 7094.7, Aftermarket Automotive Parts—Additional Funding

This is a request for additional funds to be approved under the annual contract for Bid No. 7094.7, Aftermarket Automotive Parts, for the purchase of aftermarket automotive parts for the school district. On September 7, 2023, the Board of Education approved an annual extension under Bid No. 7094.7, in the amount of \$3,068,737 (Resolution No. 392-23). After a fiscal review and analysis by the Montgomery County Public Schools Department of Transportation, it is anticipated that an additional \$2,300,000 in funding will be required for the purchase of the necessary aftermarket automotive parts. It is requested that the Board of Education approve this request for additional funding through August 29, 2024.

WHEREAS, Funds have been budgeted in the amount of \$2,300,000 for the additional funding request to purchase aftermarket automotive parts as needed through Bid No. 7094.7; now therefore be it
