

MEMORANDUM

To: Members of the Board of Education

From: Larry A. Bowers, Interim Superintendent of Schools 

Subject: Procurement Contracts of \$25,000 or More

WHEREAS, Funds have been budgeted for the purchase of equipment, supplies, and contractual services;
and

WHEREAS, Funds have been budgeted for the purchase and financing of 76 school replacement copiers
for the Department of Materials Management awarded through RFP No. 4247.2, in the amount of \$450,000;
and

WHEREAS, The acquisition of school replacement copiers through financing agreement has been reviewed
by legal counsel; now therefore be it

Resolved, That school replacement copiers in the amount of \$450,000 be purchased and financed
for a four-year term under the Master Lease/Purchase Agreement with Banc of America Public Capital
Corporation; and be it further

Resolved, That the proceeds from the aforementioned financing be used to reimburse
Montgomery County Public Schools accounts to the extent that such equipment has been or will
be acquired before closing; and be it further

Resolved, That the president of the Board of Education and the interim superintendent of schools
be authorized to execute the documents necessary for these transactions; and be it further

Resolved, That having been duly advertised, the following contracts will be awarded to the low bidders
meeting specifications as follows:
