

Subject: Contract Approval for RFQ No. 1155.4, Digital Content Products for MDK12 Digital Library Consortium—Extension

This is the second, one-year renewal to pre-qualify online digital content products to include nine product additions, on behalf of the MDK12 Digital Library Consortium (MDK12 Consortium), a statewide purchasing consortium of the 24 local school systems (LSS) in Maryland. The MDK12 Consortium is designed to provide teachers, students, parents and guardians cost-effective access to a collection of appropriate online digital content products to support school library media programs, and to offer enhanced opportunities to support effective teaching and learning for Grades K–12 students at a savings to each LSS. As a member of the MDK12 Consortium, Montgomery County Public Schools (MCPS) acts as the soliciting agent on behalf of the other 23 LSS to pre-qualify online digital content products for purchase by MDK12 Consortium members. The pre-qualified online digital content products include online subscription databases and electronic library resources.

The MDK12 Consortium's purchasing authority is set forth under the Annotated Code of Maryland, Education, Sections 7-9A-01 through 7-9A-05. As stated in this statute, the purposes of the MDK12 Consortium are to:

- provide equitable access to digital content for all Maryland K–12 students and teachers;
- improve school library media programs with advanced technologies;
- create fiscal efficiencies in the purchase of digital content through enhanced cooperation among school libraries; and
- support effective teaching and learning by connecting digital content with the Maryland Content Standards; Science, Technology, Engineering, and Mathematics initiatives; and workforce development.

Members of the MDK12 Consortium began working together in 2002 to purchase online digital content products. Since that time, the MDK12 Consortium has leveraged the LSS' collective resources to negotiate pricing with providers of online digital content products to serve approximately 850,000 public school students and over 42,000 nonpublic school students enrolled in Grades K–12 across the state of Maryland. The benefits of purchasing through the MDK12 Consortium include greater equity of access, cost savings to LSS, shared professional development, and effective partnerships among school librarians.



To facilitate the continued purchase of online digital content products through the MDK12 Consortium, MCPS released on February 25, 2019, Request for Qualification No. 1155.4, Online Digital Content Products for the MDK12 Digital Library Consortium, to solicit high-quality online subscription databases and electronic library resources. MCPS staff organized and conducted a thorough product selection process with representatives from members of the MDK12 Consortium. The period of the pre-qualification award is an initial three-year term with up to three, one-year options to renew.

In accordance with the outcome of the product selection process, the superintendent of schools recommends that the Board of Education approve certain pre-qualified online digital content products for purchase by LSS participating in the MDK12 Consortium, for an additional one-year term through June 30, 2024.

In addition, regarding MCPS purchases of pre-qualified online digital content products, funds have been budgeted for Fiscal Year 2024, for MCPS offices and schools to purchase pre-qualified online digital content products, in an amount not to exceed \$1,500,000.

WHEREAS, As a member of the MDK12 Digital Library Consortium, Montgomery County Public Schools acts as the soliciting agent on behalf of the other 23 Maryland local school systems to pre-qualify online digital content products for purchase by MDK12 Digital Library Consortium members; and

WHEREAS, To facilitate the continued purchase of online digital content products through the MDK12 Digital Library Consortium, Montgomery County Public Schools released on February 25, 2019, Request for Qualification No. 1155.4, Online Digital Content Products for the MDK12 Digital Library Consortium, to solicit high-quality online subscription databases and electronic library resources; and

WHEREAS, Montgomery County Public Schools staff organized and conducted a thorough product selection process with representatives from members of the MDK12 Consortium; and

WHEREAS, In accordance with the result of the product selection process, the superintendent of schools recommends that the Board of Education approve certain pre-qualified online digital content products for purchase by local school systems participating in the MDK12 Consortium through June 30, 2024; and

WHEREAS, The period of pre-qualification under Request for Qualification No. 1155.4 is an initial three-year term with up to three, one-year options to renew. This is the second of three one-year extensions; and

WHEREAS, Funds have been budgeted for Montgomery County Public Schools offices and schools to purchase pre-qualified online digital content products in an amount not to exceed \$1,500,000 for fiscal year 2024; now therefore be it

Resolved. That the following online digital content products are pre-qualified for purchase by each Local School System participating in the MDK12 Digital Library Consortium in its discretion, and in accordance with the specifications of Request for Qualification No. 1155.4, through June 30, 2024:



Subject: Contract Approval for RFP No. 1072.4, Master Lease Financing

Master Lease Financing, Request for Proposal No. 1072.4 was issued on January 27, 2023, for a master lease financing agreement to provide lease financing to Montgomery County Public Schools (MCPS) for the acquisition of school buses, technology modernization equipment, energy savings programs, and other essential vehicles and equipment for the next three years.

On March 7, 2023, the Montgomery County Board of Education received proposals for financing under Request for Proposal Number 1072.4, and has determined that Banc of America Public Capital Corporation is the financing vendor offering the most favorable equipment financing through a master lease/purchase program, and the most favorable financing for implementation of energy programs. The structure of the new Montgomery County Public Schools Master Lease Agreement provides for a three-year agreement to provide lease financing for the acquisition of essential vehicles and equipment. Based on past lease financing activity, approximately \$240 million in vehicle and equipment acquisitions are expected to be financed during the three-year period of the agreement. The Master Lease Agreement includes the option to extend the term for two additional three-year periods. Acquisitions eligible for inclusion in the Master Lease Agreement would be authorized in the operating budget, capital budget, competitively bid, and approved by the Board of Education prior to purchase.

Upon evaluation and the completion of a rate survey of other local jurisdictions by MCPS staff, we found the rates proposed by Banc of America Public Capital Corporation favorable.

The following resolution has been reviewed by the Office of the General Counsel.

WHEREAS, On January 27, 2023, Request for Proposal No. 1072.4, seeking proposals for preferred municipal master lease financing was duly advertised; and

WHEREAS, On March 7, 2023, the Board of Education received proposals for financing under Request for Proposal No. 1072.4, and has determined that Banc of America Public Capital

Corporation is the financing vendor offering the most favorable equipment financing through a master lease/purchase program; and

WHEREAS, Banc of America Public Capital Corporation has agreed to provide the required financing for essential vehicles and equipment, at a preferred municipal rate; and

WHEREAS, Banc of America Public Capital Corporation has agreed to provide the required financing for implementation of energy programs; and

WHEREAS, The Board of Education is being requested to authorize the master lease program as first consideration for the source of financing the acquisition of school buses, technology modernization equipment, energy savings programs, and other essential vehicles and equipment needed through June 30, 2026; now therefore be it

Resolved, That the Board of Education award Request for Proposal No. 1072.4 to Banc of America Public Capital Corporation, for a Master Lease Agreement through June 30, 2026, in accordance with the bid specifications and the bidder's proposal, subject to the non-appropriation clause as set forth in the Master Lease Agreement documents; and be it further

Resolved, That the Board of Education authorize proceeds from the aforementioned financing be used to reimburse Montgomery County Public Schools accounts to the extent that such equipment has or will be acquired before closing; and be it further

Resolved, That the superintendent of schools and the Board of Education president are authorized, empowered, and directed to approve, execute, and deliver on behalf of the Board of Education the documents necessary to implement this Master Lease Agreement and related documents with whatever changes may be necessary or appropriate.
