Subject: Contract Approval for Bid No. 9103.12, Groceries, Staples & Spices—Extension

Superintendent Recommendation:

The superintendent recommends that the Board of Education approve the extension of Bid No. 9103.12, Groceries, Staples & Spices, under the Annotated Code of Maryland, Education Article §5-112 and Montgomery County Public Schools Regulation DJA-RA, *Procurement of Equipment, Supplies, and Services*.

This is a request to exercise the first extension of the third, two-year term for Bid No. 9103.12, for the purchase of groceries, staples, and spices, used in schools by the Department of Food and Nutrition Services (DFNS). It is recommended that the Board of Education approve this contract extension for one year through July 31, 2027.

DFNS is an enterprise fund, which means that it is designed to be self-sustaining, relying on the revenue generated from the sale of school meals and other food items to cover its operational costs. Thus, no funds from the Montgomery County Public Schools operating budget are used to make these purchases.

All food purchased and served to students meets or exceeds the following federal and state requirements:

- 7 CFR 210.10 Meal requirements for lunch
- 7 CFR 220.8 Meal requirements for breakfast
- 7 CFR 210.11 Competitive food service standards, including Smart Snack standards
- Maryland Nutrition Standards for All Foods Sold in School

WHEREAS, Funds have been budgeted in the amount of \$1,330,065 for the purchase of menu items under Bid No. 9103.12; now therefore be it
