Superintendent Recommendation:

The superintendent recommends that the Board of Education approve Bid No. 9111.7, Pizzas, Baked-Frozen—Extension.

The Division of Food and Nutrition Services (DFNS) is an enterprise fund, which means that DFNS is designed to be self-sustaining, relying on the revenue generated from the sale of school meals and other food items to cover its operational costs. Thus, no funds from the Montgomery County Public Schools (MCPS) operating budget are used to make these purchases.

All food purchased and served to students meets or exceeds the federal and state requirements below:

- 7 CFR 210.10 Meal requirements for lunch
- 7 CFR 220.8 Meal requirements for breakfast
- 7 CFR 210.11 Competitive food service standards including Smart Snack standards
- Maryland Nutrition Standards for All Foods Sold in School

This is a request to exercise the second of three annual extensions for Bid No. 9111.7, for the purchase of frozen pizza served in schools by the Division of Food and Nutrition Services. It is recommended that the Board of Education approve this contract extension for one year through June 30, 2026.

WHEREAS, Funds have been budgeted in the amount of \$3,432,656 for the purchase of frozen pizza through Bid No. 9111.7; now therefore be it
