Subject: Procurement Contracts of \$25,000 or More

WHEREAS, Funds have been budgeted for the purchase of equipment, supplies, and contractual services; and

WHEREAS, Funds have been budgeted for the purchase and finance of off-the-lot new vehicles and equipment through Bid No. 1114498, in the amount of \$230,380; and

WHEREAS, Funds have been budgeted for the purchase and finance of off-the-lot, new and used vehicles through Bid No. B-1560 in the amount of \$342,648; now therefore be it

Resolved, that off-the-lot new vehicles and equipment be purchased and financed for a five-year term in the amount of \$230,380 under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation; and be it further

Resolved, that off-the-lot, new and used vehicles be purchased and financed for a five-year term in the amount of \$342,648 under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation; and be it further

Resolved, that the proceeds from the aforementioned financing be used to reimburse Montgomery County Public Schools accounts to the extent that such vehicles have been or will be acquired before closing; and be it further
