Subject: Contract Approval for Bid No. 9224.1, Special Diets and Global Flavors

Information Action

Superintendent Recommendation:

The superintendent recommends that the Board of Education approve Bid No. 9224.1, Special Diets and Global Flavors, under the Annotated Code of Maryland, Education Article §5-112 and Montgomery County Public Schools Regulation DJA-RA, *Procurement of Equipment, Supplies, and Services*.

This is a request to approve a new annual contract for Special Diets and Global Flavors under Bid No. 9224.1. This bid will expand the menu items served in the Montgomery County Public Schools (MCPS) meals program for students with special dietary needs and introduce diverse global flavors. It is recommended that the Board of Education approve this contract for one year through May 21, 2027.

The Division of Food and Nutrition Services operates as an enterprise fund, meaning that it is designed to be self-sustaining and relies on the revenue generated from the sale of school meals and other food items to cover its operational costs. Thus, no funds from the MCPS operating budget are used to make these purchases.

All food purchased and served to students meets or exceeds the following federal and state requirements:

- 7 CFR 210.10 meal requirements for lunch
- 7 CFR 220.8 meal requirements for breakfast
- 7 CFR 210.11 competitive food service standards, including Smart Snack standards
- Maryland Nutrition Standards for All Foods Sold in Schools

WHEREAS, Funds have been budgeted in the amount of \$2,327,650 for the purchase of menu items under Bid No. 9224.1, now therefore be it.
