Subject: Procurement Contracts of \$25,000 or More

WHEREAS, Funds have been budgeted for the purchase of equipment, supplies, and contractual services; and

WHEREAS, Funds have been budgeted for the purchase and financing of two refrigerated cargo trucks for the Division of Food and Nutrition Services, Bid No. 7104.7, Refrigerated Cargo Trucks, in the amount of \$279,790; and

WHEREAS, The acquisition of two refrigerated cargo trucks through financing agreements has been reviewed by legal counsel; now therefore be it

Resolved, That two refrigerated cargo trucks be purchased and financed for a six-year term in the amount of \$279,790 under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation; and be it further

Resolved, That the proceeds from the aforementioned financing be used to reimburse Montgomery County Public Schools accounts to the extent that such equipment has been or will be acquired before closing; and be it further

Resolved, That the Board of Education president and the superintendent of schools be authorized to execute the documents necessary for these transactions; and be it further

Resolved, That having been duly advertised, the following contracts be awarded to the low bidders meeting specifications as follows:
