WHEREAS, Funds have been budgeted for the purchase of equipment, supplies, and contractual services; and

WHEREAS, Funds have been budgeted for the purchase and finance of multiple vehicles with related equipment and accessories through Bid No. 091521-NAF, in the amount of \$69,304; and

WHEREAS, Funds have been budgeted for the purchase and finance of multiple vehicles including utility and service vans through Bid No. 1114498, in the amount of \$951,250; and

WHEREAS, Funds have been budgeted for the purchase and finance of two all terrain mowers and a chipper through Bid No. 7118.10, in the amount of \$166,683; and

WHEREAS, Funds have been budgeted for the purchase and finance of a trash compactor truck through Bid No. 7143.5, in the amount of \$178,556; and

WHEREAS, The acquisition of multiple vehicles with related equipment and accessories, multiple vehicles including utility and service vans, and two all terrain mowers, a chipper and a trash compactor truck through financing agreements has been reviewed by legal counsel; now therefore be it

Resolved, That multiple vehicles including utility and service vans be purchased and financed for a five-year term in the amount of \$951,250 under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation; and be it further

<u>Resolved</u>, That multiple vehicles with related equipment and accessories be purchased and financed for a six-year term in the amount of \$69,304 under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation; and be it further

Resolved, That two all terrain mowers and a chipper be purchased and financed in the amount of \$166,683 under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation; and be it further

Resolved. That a trash compactor be purchased and financed for 5-year term in the amount of \$178,556, under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation; and be it further

<u>Resolved</u>, That the proceeds from the aforementioned financing be used to reimburse Montgomery County Public Schools accounts to the extent that such equipment has been or will be acquired before closing; and be it further
