



MEMORANDUM

To: Members of the Board of Education

Subject: Procurement Contracts of \$25,000 or More



WHEREAS, Funds have been budgeted for the purchase of equipment, supplies, and contractual services; and

WHEREAS, Funds have been budgeted for the purchase and finance of off-the-lot new vehicles and equipment through Bid No. 1114498, in the amount of \$370,723; and

WHEREAS, It is recommended that Bid No. 40951.1, Energy Efficient Lamps be rejected due to pricing and lack of bids received; and

WHEREAS, It is recommended that RFP No. 4290.4, Private Duty Nursing Services for Students with Special Needs be rejected due to lack of bids received; and

WHEREAS, Funds have been budgeted for the purchase and finance of refrigerated cargo trucks through Bid No. 7104.8, in the amount of \$540,750; and

WHEREAS, The acquisition of off-the-lot new vehicles and equipment and refrigerated cargo trucks through financing agreements has been reviewed by legal counsel; now therefore be it

Resolved, That off-the-lot new vehicles and equipment be purchased and financed for a five-year term in the amount of \$370,723 under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation; and be it further

Resolved, That Bid No. 40951.1, Energy Efficient Lamps be rejected due to pricing and lack of bids received; and be it further

Resolved, That RFP No. 4290.4, Private Duty Nursing Services for Students with Special Needs be rejected due to lack of bids received; and be it further

Resolved, That refrigerated cargo trucks be purchased and financed for a five-year term in the amount of \$540,750 under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation; and be it further

Resolved, That the proceeds from the aforementioned financing be used to reimburse Montgomery County Public Schools accounts to the extent that such equipment has been or will be acquired before closing; and be it further

Resolved, That having been duly advertised, the following contracts be awarded to the low bidders meeting specifications as follows:
