WHEREAS, Funds have been budgeted for the purchase of equipment, supplies, and contractual services; and

WHEREAS, Funds have been budgeted for the purchase and financing of multiple vehicles with related equipment and accessories through Bid No. B-1560, Off the Lot, New and Used Vehicles in the amount of \$259,509; and

WHEREAS, Funds have been budgeted for the purchase and financing of a trash compactor truck through Bid No. 7143.6, Trash Compactor Truck, in the amount of \$211,750; now therefore be it
