

MEMORANDUM

 Subject: Procurement Contracts of \$25,000 or More

WHEREAS, Funds have been budgeted for the purchase of equipment, supplies, and contractual services; and

WHEREAS, Funds have been budgeted for the purchase and finance of refrigerated cargo trucks through Bid No. 7104.8 in the amount of \$360,500; and

WHEREAS, Funds have been budgeted for the purchase and finance of two Chevrolet Silverado 4X4 trucks and accessories through Bid No. B-1560 in the amount of \$214,997; now therefore be it

Resolved, That refrigerated cargo trucks be purchased and financed for a five-year term in the amount of \$360,500 under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation; and be it further

Resolved, That two trucks with related equipment and accessories be purchased and financed for a six-year term in the amount of \$214,997 under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation; and be it further
