Subject: Procurement Contracts of \$25,000 or More

WHEREAS, Funds have been budgeted for the purchase of equipment, supplies, and contractual services; and

WHEREAS, Funds have been budgeted for the purchase and financing of multifunctional device equipment, supplies and software, and service solutions awarded through Bid No. FI-R-0251-18, in the amount of \$50,000; and

WHEREAS, the acquisition of multifunctional device equipment, supplies and software, and service solutions through financing agreement has been reviewed by legal counsel; now therefore be it

Resolved, That the multifunctional device equipment, supplies and software, and service solutions be purchased and financed in the amount of \$50,000 for a five-year term under the Master Lease/Purchase Agreement with Banc of America Public Capital Corporation, and be it further

Resolved, That the proceeds from the aforementioned financing be used to reimburse Montgomery County Public Schools accounts to the extent that such items have been or will be acquired before closing; and be it further

Resolved, That the president of the Board of Education and the interim superintendent of schools be authorized to execute the documents necessary for these transactions; and be it further

Resolved, That having been duly advertised, the following contracts be awarded to the low bidders meeting specifications as follows:
