The existing drawings state that the floor finish on the lower level (LL) is Terrazzo Tile in front of the elevator, while the upper level features VCT. Some work was done on the LL, and it appears as if some of the Terrazzo tiles were replaced with VCT. (See Screenshot). The GC is required to match these finishes and later submit samples for MCPS approval.
11.	Fairland Elementary School: Please provide the full drawing set so the project can be accurately priced. The provided drawing set is missing the following drawings: MP000, MP100, MP300, E001, E002, and E003.	Full set attached.
12.	Approximately when will be the anticipated NTP?	June 2025.
13.	Will damp-proofing of the elevator pit floors and walls be required for this project?	No.
14.	Please clarify the extent/scope for the elevator parts and labor warranty that is to be provided with the base bid scope.	Project is covered by the two year warranty for full scope of the project.
15.	Please define the extent/scope for the elevator maintenance that is to be provided with the base bid scope.	Quotation items #3 & #6 are not included in the base bid scope.
16.	If MCPS elects to not accept the segregated pricing for elevator maintenance, will the contractor be required to respond to elevator callbacks due to warranty issues for the installed materials even if the elevator equipment is not actively maintained.	Elevator will be maintained as required by code. Bidder will warranty project as specified.
	We recommend including the elevator maintenance in the base bid and revising the bid form to eliminate any potential defects caused by neglected elevator maintenance within the 2 year warranty period.	Maintenance and Capital projects are funded from two different budgets.
