Question 1 The RFI Key Information Summary Sheet states "Send Questions and Response (email only) to Stephanie\_J\_Dorah@mcpsmd.org"; however, Section 3.1 includes hardcopy and flash drive requirements to be sent by mail, courier, or hand-delivery. Those instructions seem extraneous and unnecessary. Please confirm that RFI responses will be accepted via email to the address provided on page 2.

**Question 2** Would MCPS please provide the estimated quantities for purchase? Previous year purchase information would be appreciated as well to help vendor obtain bulk pricing from the OEMs. How are the quantities spread between Chromebook, laptop, desktop, and Apple devices?

Question 3 What kind of warranty service uplift is required (onsite, hot swap, spare part purchase, accidental protection)? Based on the SOW, it looks like MCPS has its own repair site, and will purchase repair parts from the vendor.

**Answer:** MCPS has the capability to repair hardware. We expect to be able to do that unless the provided option does not allow for end-user repairs. If self repairs are not possible, we will need terms for spares and/or warranty information for our technical staff to provide a timely replacement to the affected end user. Onsite support is not expected from the hardware vendors.

**Question 4** The solicitation invitation references Round #2, are there any restrictions in our participation for this round?

Answer: No restrictions not stated in the RFI. At this time, there are no plans for a round 2 or an RFP.
